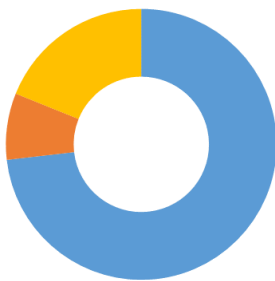

During the past year we have invested in a role to support greater volunteerism in our community, implemented an on-going loaned executive program, and strengthened our board governance and organizational policies and procedures-all to better serve our community.

Thanks to all of us who comprise our community-donors, service providers, volunteers, staff, and Board members- we are making a difference in our region and are driving results.

CAMPAIGN CHAIR REPORT

As I write this report, I am struck by how quickly a year goes by! When first approached to be the Campaign Chair for 2016-17, I recall feeling excitement, pride, and a bit of fear. Excitement to immerse myself in the organization I have been supporting for my entire professional life; proud that I would have the opportunity to be closely associated with this well-respected, important anchor organization in MY community; and yes, fear mixed in that perhaps I would

fall flat and simply not do the position justice. Staff were infinitely patient, acclimating me to the position and answering thousands of questions along the way. The UWTVA Board has been very supportive and encouraging as well and they also have my appreciation and gratitude. I would be remiss if I did not also extend my appreciation to the community members and volunteers I have engaged with throughout the year. And lastly, but surely not least, I wish to extend a HUGE Thank You to the cabinet members this year: Bruce Manzer, Ken Lust, Pam Ernest, Gayle Long, and the staff.

This has indeed been a year in transition. My charge at the outset was to diversify our outreach, find creative ways to engage the public, and form new partnerships. Like all industries, the non-profit world is facing challenges and we need to adapt the way we are doing business. The Community Change Challenge is one example of a new and creative way to increase visibility, engage folks, and increase funds. We continue to grow and adapt the Great Charity Auction event due to generous donations and outreach to increase participation. We formed a new partnership with Sandy River Realty as a corporate partner that we expect to replicate, but not duplicate. The Cabinet and Events committee will collaborate in the coming year for more innovative ways to create support.

Despite some significant reductions in certain donation areas, we are in good stead, having raised more than **\$553,000** to date in dollars, goods, and volunteer service. We will continue to move the mercury on our thermometers until the very last moment when the campaign ends April 30. We have laid the groundwork for the coming years, diversifying the revenue stream and increasing public awareness of our work.

What's Next? Only time will tell, but I definitely wanted to be a part of it for at least the next campaign year so I have decided to remain another year as the Campaign Chair and have already begun the process to assemble the cabinet to support our efforts. As I was reflecting on the progress this past January, it became very clear that I wanted and needed to stay on to see this through. I couldn't be more excited.

Here's where all of you reading this can help. If you are taking the time to read this, you have a passion as well for this anchor organization. Talk in your circles about the good work of UWTVA and encourage them to donate, volunteer, or advocate in some way. And I ask the same of all of you. This is Your Community-Invest in Your Community.

I have learned so much about UWTVA; what stands out most is the people I have met along the way—humble, hard-working people who never seek credit for what they do, day in and day out, but are making a significant difference in the lives of our friends, and family. Step up, look deeper, and join me in the experience that is United Way.
